

## Privacy Policy

The purpose of this Privacy Policy is to inform users of the website [www.Brunnei.net](http://www.Brunnei.net) and the Brunnei app (hereinafter collectively referred to as "the Site") about the privacy policy practiced by Brunnei International Ltd. (the "Company"), including how the Company collects and uses information. The Company reserves the right to modify or change the Privacy Policy from time to time, and your continued use of the Site and/or the services offered by the Site after the updated Privacy Policy is published constitutes your agreement to the changes. If you are under 18 years old, you confirm that this Privacy Policy has been approved by your parents and/or legal guardian. If this is not the case, you are required not to use the Site and not to share any information about yourself.

The Site collects information about users with the purpose of providing the services they request and/or improving the quality of the services offered. There are two types of information collected:

**General Information** - General information about the users of the Site, collected in an aggregated and anonymous manner to improve and enhance the quality of the services provided through the Site, in such a way that no personally identifiable information is associated with the data. General information may include, for example, the pages visited, the time spent on each page, the content viewed, and similar data.

**Personal Information** - Information collected from users and stored in the Company's databases, which is personal in nature, such as: your name, email address, business address, etc. Personal information is collected only when users voluntarily provide it, such as when entering their details during registration to receive a service through the Site. Additionally, personal information includes data collected by us about users as part of the services provided, including models, designs, programs, etc. The Company uses the personal information to respond to users' needs and provide the services for which the Site is intended.

Any information you provide while using the Site remains your property at all times. However, by providing or allowing the collection of such information on the Site, you agree that the Company has the right to use this information for the purpose of providing services on the Site, conducting statistical analyses, data segmentation, and sending postal mail, including marketing and promotional content.

The Company may store collected information in its databases and use it in accordance with the terms of use, privacy policy, and applicable laws.

For the ongoing operation of the Site, including information collection, data verification, and adjusting the Site to your preferences, the Site uses and/or will use "cookies." Cookies are text files created by the user's browser upon command from the Company's computers. Some

cookies will expire when you close your browser, while others are stored on your computer's hard drive. Cookies contain various information such as the pages you visited, the time spent on the Site, the source of your visit, sections, and user preferences. The information in cookies is encrypted, and the Company takes precautions to ensure that only its computers or authorized parties can read and understand the stored information. If you wish to prevent cookies from being set by the Site, you must change the settings in your operating system or browser. You can also delete these files from your computer at any time.

The Site contains links to external sites and relies on information from third parties. You are aware that the Company does not guarantee that such information is reliable or accurate and has not verified the reliability of such third-party information. The Company will not be responsible for any damage, loss, or liability of any kind incurred by you as a result of relying on such information.

The Company uses standard industry precautions to protect the confidentiality of the information received from you. However, despite these measures, there is always a risk of unauthorized access to the Site's databases and data transmission between your computer and the Site. Therefore, you agree that the Company will not be liable for any loss, damage, or costs incurred by you (if any) resulting from unauthorized access to the Site's database and/or transmission of your information or information you provided to a third party, as long as reasonable and acceptable steps were taken to prevent such actions.

Any payment made through the Site using a credit card is encrypted according to standards. The Site and/or its owners will not be liable for any damage of any kind, direct or indirect, if this information is lost or used without authorization.

The Company will not sell or transfer information about you to others without your prior consent, except in the following cases: (a) if required by law or a court order; (b) if there is a dispute between you and the Company regarding the information; (c) if the use of the Site violates the terms of use, privacy statement, or any legal requirements; (d) if non-personally identifiable information is shared, such as browsing habits and statistical data; (e) if the information is shared with service providers or employees of the Company for the purpose of providing services through the Site.

The Company will not be considered in breach of privacy or violating user privacy due to any information, as defined in the Computers Law, 1995, that could identify a user or track them by others, resulting from the use of electronic communication in general and computer communication in particular. The requested details will be deleted within 3 business days, except for minimal details that we are required to retain by law or at our discretion.
